C. Reports to Committee

Director Dejung's report

Director Dejung stated current staffing is -3. Class of 6 will start October 30, 2017, 4 FTE pre hires and 2 (0.5 FTE). Ashley Sweeney was promoted to Supervisor. Attrition is at 11%, better than in past few years. Process times continue to be at 96%/15 sec for 9-1-1 answer times. Kevin Fosso is now a member of the NFPA Committee for 1221.

October 24, 2017, Solacom phone system will go live. Training for all staff has completed, and there will also be communicators who are "power users" to help assist in this cutover.

Future topic for this group will be revisiting how to handle abandoned Phase 1 and Phase 2 911 calls.

No feedback from users on any Tri Tech issues. ASAP to PSAP is underway, ADT coming on board in the next month.

There had been "6" outage with the radio system. September 14, there was 14 min outage which was technician related. Outage #2 was less than 1 minute, and effected law enforcement only. Outage #3 had small impact due to a microwave issue and was 1min 49sec. Outage #4, was on October 6, was 4 minutes due to equipment failure. Outage #5 and #6 were on October 7, due to the tornado, as well as Sun Prairie lost power and back up power, Fitchburg also had console issues not DaneCom related.

Marquette County was being interfered by our 4th channel despite it being authorized by the FCC. Looking for solutions on this, possibly moving the 4th channel down to the 10th position.

Space study has been placed on hold. East District Campus is operational and ready to be used if necessary as our back up center.

Report to the Madison PSRC meeting group went well, with no feedback after the meeting.
