Koenig presented a revised draft of the high school survey incorporating input from the last Steering meeting. Committee completed the review of the survey and tabled the vote until the survey is piloted by youth and any subsequent revisions are made at the next meeting. Revisions from today's meeting include:

- #83—Typo in option "Chewing tobacco"

• Re-order AODA section--#84 is 30-day use. Change last three options to "10 or more days"

- Add Tobacco 30-day use item with same answer options
- Make access to tobacco #86 & 12-month use #87
- Remove skip function from AODA section given reduction in survey items
- #88 change response #3 to 3 to 5 days
- #90 change to "in the past 12 months..."
- #92 change option #3 to "3 to 5 days"
- #94 change to "Below are statements..."
- #99 Remove third line—redundancy. Add option of using e-cigs. Add option "Have 1 or 2 drinks of an alcoholic beverage nearly every day."
- #102 add "Have 1 or 2 drinks of an alcoholic beverage nearly every day."
- #103 remove "report card" language
- Add item after #106 on "Do you take AP classes" Y/N
- #109 Extra circles—remove
- #112—Discussion on adding micro-aggressions questions. Opted not to add. Will get input from youth at the pilot.
- #118 Add SES option
- #124 Move to front of survey—after #22
- #125 Add line on "Finding resources for help"

Youth pilots will be held on 8/15 at West High School with five students and at the Lussier Community Education Center on 8/16 with ten students. Students will take survey as if in school to be followed by a structured Q & A. Youth input will be reviewed at the next DCYA Steering meeting.
