Information sharing is discussing how to best communicate urgent concerns to EMS providers. System Health is looking at Ketamine and Pediatric Airway data and creating a SEPSIS protocol. Community Engagement is working on the County role in Community Paramedicine (aka mobile integrated healthcare). Also, the protocol revision group is meeting again to work thru the updates for 2018.
