Review draft Lakes & Watershed Commission Stormwater Volume Resolution

Power recapped next steps to follow up on the Stormwater Technical Advisory Committee recommendations, including the joint work group of the Commission and Capital Area Regional Planning Commission (CARPC) to flesh out a fee-in-lieu program to offset costs of increased volume control. Members reviewed the draft Commission resolution, which is similar to what CARPC adopted.

A motion was made by WEST, seconded by UPDIKE, that the draft stormwater volume resolution be approved and recommend approval by the full Commission. The motion carried by the following vote: 5/0

#### 2. Status of 2018 Budget Recommendations

The Commission's 2018 budget recommendations were submitted to the County Executive, posted on the website, and shared with the community on August 31. Power has briefed the County Executive's office and County Board Chair about the recommendations, and Updike has briefed the Towns Association. Jones will mention these recommendations as part of her upcoming Cities and Villages Association presentation. Commission members have planned several additional follow-up conversations about the recommendations.

#### 3. Commission Work Groups Status

Chlorides – McCarville is introducing Res. 214 tonight, endorsing the application rate guidelines and voluntary certification program.

Phosphorus – Power said that the Healthy Farms Healthy Lakes Task Force initial meetings have gone well.

Equity – Jones said that the Parks Commission is very interested in developing its own equity and inclusion statement, modeled after the Commission's.
