skills training (budgeting, cooking, household maintenance, etc.), advocacy,
assistive technology (devices that eliminate barriers and improve
independences), accessibility assessment (improve physical and programmatic
accessibility), assistance transitioning back to living in the community, public
benefits assistance, youth program and services, deaf and hard of hearing
program and community collaboration, education, and technical assistance. The
majority of staff, as well as the Board of Directors, are people with disabilities.
Nash also provided a tour of the facility.
