*Batterman stated the Area Plan Advisory Council approved the draft goals on 11 May. If approved by the Board, the draft goals will be submitted to the Wisconsin Bureau of Aging and Disability Resources (BADR) for the purpose of receiving feedback. Two public listening sessions to solicit feedback from seniors are scheduled in October – one in Oregon and one on Madison's Northside -- and seniors will be encouraged to provide feedback via an online survey. Final goals will be submitted for approval by the Advisory Council on 16 November and the AAA Board on 17 December. The final plan must be delivered to BADR by 31 December.*

*Williams contacted DCDHS Director Lynn Green at the AAA Board's behest to request policy information on out-of-state travel for staff to attend educational conferences. Williams was informed there is no policy prohibiting out-of-state travel, but that funding for such trips must come from the agency's budget. Batterman stated AAA does have a modest travel budget, the majority of which is exhausted each year by state-mandated training for Elder Benefit Specialist staff.*

*AAA Aging Program Specialist Angela Velasquez reported representatives from AAA and three Senior Focal Points – McFarland Senior Outreach Services, Oregon Area Senior Center and Stoughton Area Senior Center – met in May to discuss home-delivered meals (HDMs) delivery boundaries. The current boundaries are different than case management boundaries for these Focal Points, which causes confusion for seniors and is problematic from a funding standpoint. Velasquez will keep the Board apprised of developments.*

*Velasquez and Mohan are working with DCDHS Adult Protective Services Manager Beth Freeman to write a proposal for a \$1 million Administration for Community Living grant entitled "Alzheimer's Disease Programs to States and Communities." The funding would enhance services to dementia-afflicted seniors who live alone, would facilitate earlier assessment and care-plan execution for developmentally disabled seniors, and would expand dementia crisis work.*
