1. Discontinue Agreement between Dane County and Robinson Law Library - Chlebowski

Kristi Chlebowski explained that she and Fred lausly met with Corporate Counsel regarding the current agreement with the Robinson Map and Air Photo Library, which restricts the shared Dane County digital geographic datasets with UW students and faculty only. And although the document has historically been referred to as a "contract" it is an Agreement.

Steven Ventura motioned to disengage from the agreement. Tanya Buckingham seconded. Motion passed unanimously with a voice vote.

2. Vote on State Requirements for Open Access of Historical Data - Chlebowski

It was discussed that we needed to consider this action the passage of 2 items. 1. Historical data sent to State of Wisconsin Dept. of Administration.

2. Current data sent to State of Wisconsin Dept. of Administration, excluding aerial imagery (Fly Dane).

Violante shared that the industry is moving towards a sharing reality and since the data is our responsibility so would be the sharing. Peter Herreid clarified that the DOA request is for current and historical non-aerial imagery data. An inquiry was made regarding the names of homeowners who have opted out. It was confirmed that the names of land owners that have opted out will not be included in the data shared.

Steve Ventura motioned to permit open access of Dane County data (excluding aerial imagery). Todd Violante seconded. Motion passed unanimously with a voice vote.
