## 2. Dane County Budget Presentation - Joe Parisi, Dane County Executive, & Lynn Green, Dane County Human Services Director

*Review of the COSC letter to County Executive re: Diversifying Commission. Geographic representation issue - looking for suggestions as to how that would help broaden membership as most of the agency members cover the county through services. Discussion about this and how to implement and/or what the need is. Is CCR a better area to gather info? How do we include community members or other agency members to make it more representative?*

*Re: Voting member for anti-racism purposes*

*Re: commission member term limits - reason for and purpose of. Further discussion will take place. What is/has been role of COSC? Historically has been an arm to change policy or consult on policy in an inter-agency manner. How much have we turned into a Commission that is information sharing vs. action?*

*Budget:*

- *Building Bridges - increase in funding and expansion.*
- *First responder training for MH incidents, including 911*
- *County-wide assessment of MH services currently available. MA reimbursement increase for outpatient services may help providers and getting people in to be seen. Local HMO's have not been amenable to improving wait times for county clients.*
- *COSC LTE budget increased by \$1300*
- *3 supervisors in DCDHS - JFF, CPS, JJ*
- *Supervised visitation increased: Canopy increase \$45k and SSS will work non-standard hours to assist with visits.*
- *6 lead CPS SW's will be created from existing positions.*
- *Family Care will be expanded.*
- *CRC and Restorative justice services increased.*
- *Matt Tye - Sensitive Crimes cases are far away from being referred to CRC. How do we consult with CRC as the program grows?*
