## C. Action Items

1. Discussion and Possible Action on 2019 City of Madison/Dane County Budget Recommendations

*Motion by Wegleitner, seconded by Ritt, to recommend that Dane County allocate an additional \$3 million in capital funds for the Affordable Housing Development Fund (AHDF), bringing the fund to \$6 million total in 2019, and near the level of what was requested from projects in 2018's round of funding. Motion carried unanimously.*

*Motion by Wegleitner, seconded by Ketchum, to recommend that City of Madison allocate an additional \$1.5 million in capital funds for the City of Madison's Affordable Housing Development Fund to meet the demands for funding in this area and to support the development of additional affordable units. Motion carried unanimously.*

*Motion by Wegleitner, seconded by Ketchum, to recommend that Dane County allocate an additional \$110,000 in funding for supportive services for permanent housing, to be awarded via a RFP processes in 2019. Motion carried unanimously.*

*Motion by Wegleitner, seconded by Ketchum, to recommend that City of Madison allocate an additional \$70,000 for rapid rehousing funds for single adults. Motion carried unanimously.*

*Motion by Ketchum, seconded by Ritt, to recommend that City of Madison allocate an additional \$105,000 to help fund Legal Action of Wisconsin's Eviction Defense Project. Motion carried unanimously. Wegleitner abstained.*

*Motion by Wegleitner, seconded by Ketchum, to support the County Executive's proposal for additional housing navigation services in 2019. Motion carried unanimously.*

*Motion by Wegleitner, seconded by Ketchum, to transfer \$6,000 in funding, currently allocated for the County's membership in the Wisconsin Coalition Against Homelessness, to fund a membership in the Wisconsin Housing First Coalition. Motion carried unanimously.*

*Memo from the committee chairs will be sent to Dane County Board of Supervisors and City of Madison Common Council.*

## 2. Discussion and Possible Action on 2018 and 2019 Work Plan and Strategic Goals

### 3. City/County 2019 Budget Updates

#### *Dane County*

- 3.5% cost of living increase for POS agencies

#### *Economic Assistance Division:*

- \$25,000 Heart Room case management
- \$50,000 Youth Housing Navigator
- \$20,000 Housing Navigation Services
- Remainder of 2019's existing Housing Navigation Services (currently provided by CAC) plus \$70,000 housing navigator will be funded January through April, a new contract will be awarded from May through a County RFP process
- Additional \$67,000 for The Beacon

#### *Children, Youth and Families*

- Additional JFF social worker position
- \$50,000 increase in JFF eviction prevention funds
- Two additional positions to work with the Neighborhood Intervention staff, specifically in the areas of sex trafficking and youth trauma.
- Two additional positions to work with chronic child neglect cases.

#### *Adult Community Services Division*

- \$160,000 for Porchlight Safe Haven plus \$50,000 MA revenue, total \$210,000
- Off the Square Club \$40,000
- Rethke Terrace \$40,000

#### *County Capital Budget*

- \$3 million for Affordable Housing Development

#### *City of Madison Community Development Division (CDD)*

- Executive operating budget was released. 5.5% increase from last year.
- Cost to continue for homeless services and housing resources (tenant services)
- \$40,000 financial literacy for long term home buyer education requested by CDD; \$20,000 in the executive budget
- CDD operating budget with cost to continue
- \$150,000 for Emerging Opportunity Program
