## D. Presentations

### 1. CULTURAL DIVERSITY PROGRAM UPDATE

*AAA Manager Cheryl Batterman stated the \$75,000 in annual funding for the Cultural Diversity Program is provided via the Older Americans Act (OAA) and Dane County General Purpose Revenue. The program, which includes programming for African-American and Latinx individuals age 60 and over, has been contracted through the North/Eastside Senior Coalition (NESCO) for many years.*

*NESCO Executive Director Jim Krueger stated the program served 187 individuals during the 2017-18 program year that ended on 30 September. Cultural Diversity staff also provide support and resources to seniors who do not attend programming, although those contacts do not count toward service totals. Transportation is provided to classes and events.*

*Rodrigo Valdivia, Cultural Diversity Specialist for the Latinx program, stated programming includes a multicultural health fair, summer concerts, art classes, computer classes, exercise classes, cooking classes and social outings with the goals of reducing feelings of isolation and maintaining high cognitive and physical function. In the new program year, Valdivia will focus on the mental health of Latinx seniors experiencing anxiety caused by the current political climate and on using Dane County Senior Dining Sites to reach more seniors. There will be continued efforts to take programming, which traditionally has been held primarily at the Madison Senior Center in downtown Madison, to areas throughout the county.*

*Pam Bracey, Cultural Diversity Specialist for the African-American program, retired in October. The hiring process to replace Bracey will commence soon.*

*When asked by Batterman if there are any barriers for seniors to access Cultural Diversity Program services, Krueger responded the program is always in need of Spanish-speaking volunteers and additional funding for transportation.*
