Dea Larsen Converse (Friends of Starkweather Creek) – recently reported a large plume of sediment runoff to the City of Madison. The process was very challenging because the reporting system is difficult to navigate. There is a need for a one-stop place where citizens could report these events when they see them. She is a member of a watershed group and took the time to figure out how to report but it was challenging and might deter many local residents. If this runoff was indeed legal then there is the need for a bigger discussion on why and what can be done. Once reported, the City was very quick to email and follow up letting her know that they sent out staff to look at the issue.

Vice Chair UPDIKE commented that there should be a conversation with the City and County on how to give better instructions or make a more user friendly system. Chair POWER agreed to follow up with the City to begin this discussion.
