AAA Aging Program Specialist Angela Velasquez provided an overview of the goals in draft form that will be submitted to the Advisory Council and answered Committee Members' questions.

2. COMMITTEE MEMBERSHIP

Velasquez reported Committee terms have ended for Patrick Downing and Vera Riley. The AAA Board appointed former Nutrition/Wellness Committee Member Carole Kretschman to a new term on the Committee during its April meeting. A community member and an EMMCA staff member have expressed interest in filling the Committee's remaining open position.

3. CHAIR & STAFF REPORTS

Velasquez reported AAA staff are working closely with two caterers -- Consolidated Food Service and Goodman Community Center -- regarding the preferences of senior diners and the quality and consistency of meals.

Velasquez reported AAA staff continue to stress the benefits of converting the Elderly Nutrition Program to the Oliver paper meal tray and bowl system for Home Delivered Meals and suggest this initiative be made an advocacy priority for the 2019 budget. The Oliver system meal trays, which are biodegradable and made from recycled materials, make it easier for seniors to reheat meals and would save approximately 70,000 aluminum trays and Styrofoam containers from winding up in landfills in 2019 and beyond. AAA's Access Committee endorsed making the initiative a 2019 budget priority on 9 April. If AAA's Legislative/Advocacy Committee endorses the initiative on 25 April, it will be forwarded for the AAA Board's consideration.

Velasquez reported the full cost of a congregate meal in 2018 dropped to \$9.73 from \$10.23.
