*The committee continued their discussion from January about a countywide process for triage and how we can meet the State requirement for MUCC compliance while still having a usable system. After much discussion the group decided that our standard would be initial triage using ribbons and SALT and then secondary triage at the treatment area would go back to SALT and use the tags we currently have on our rigs. We will request funding for the ribbon systems thru the local RTAC and the EMS association. The committee will discuss the official training plan at the March meeting. This plan was approved fully by the committee.*
