## **G. ADRC Manager's Report**

Fischer gave an update on the transition to Family Care, Partnership, and IRIS. The ADRC is ahead of schedule in meeting with current Legacy Waiver consumers. The ADRC is planning to be finished meeting with customers by the end of March.

Fischer reported that the number of customers who went into the new programs in February was less than planned. A large number of customers continue to choose IRIS and those plans take a while to be developed. There is a large number of customers who choose IRIS where the ADRC is waiting for confirmation of what their start date will be.

Barb Katz and Paul Yochum both shared their experience with the transition. The ADRC will start to work on CRI cases - which are people currently in a nursing home who want to return to the community.

The ADRC has seen a large number of FE and PD entitlement enrollments for February.

The hope is the ADRC will start to work on the waitlist in May.
