Work team reports

1. Food Waste & Recovery - Michelle Ritt provided an update on the latest work team meeting. Bryan Johnson, City of Madison Recycling Coordinator, presented on the City of Madison's food composting pilot program. Michelle shared information on the recent food waste study that was done at Leopold Elementary. She also shared that the Food Waste and Recovery Guide is in a final draft.

2. Equity and Access - Danielle Lawson provided that the team is working on the Partners in Equity grant process. They are scheduled to meet next Thursday with the staff from OEI to discuss the RFP process.

3. Urban Ag - Karen von Huene provided an update on the work of the Urban Ag team. They have been inviting people in to gather information and learn. The city of Madison Recycling Coordinator also presented to that group.

- Madison Food Policy Council – no report

- Public Health Madison/Dane County – Nick Heckman submitted a written report: Accreditation is officially underway at Public Health Madison/Dane County. This will guide the department towards National best practices in many areas of public health work. A Community Health Assessment and Community Health Improvement Plan will provide opportunities to get food access and nutrition as a priority in city/county work. The state special session on welfare reform has now closed, and several of the bills pertaining to FoodShare have passed. I will give an overview at a later day. Other than that, keep in mind that 2018 will begin negotiations on the next Farm Bill, which will have a lot of impacts on rural communities in Dane County as well as people who use SNAP/FoodShare.

- Dane County UW-Extension – Carrie Edgar shared that there is a new applicant for the Organic Certification program. We need two members of the Council to serve on the review committee. Pat Downing and Bill Warner volunteered to serve as reviewers. The final annual report was distributed. Michelle Ritt agreed to share with the other County Board Supervisors at an upcoming meeting. Edgar also shared the new book given to the Council, Stand Together or Starve Alone by Mark Winne.
