2018 Conservation Grant Requests

1. Jim Welsh (Groundswell)

Conservation Fund Grant for 10.9 acres in Town of Westport in Cherokee Marsh NRA Conservation Fund Grant for 95.5 acres in Town of Burke for Cherokee Marsh NRA

Smith provided an overview of the two grant applications that were submitted by Groundswell Conservancy that are being considered for funding. Welsh presented both of the projects, describing how they support and implement the goals for Cherokee Marsh Natural Resource Area as identified in the Dane County Parks and Open Space Plan.

2. David Walker (City of Verona)

Conservation Fund Grant 13.1 acres City of Verona for Fireman's Park Expansion in Badger Mill Creek NRA

Smith provided an overview of the project and how it fits with the Badger Mill Creek Natural Resource Area. Walker provided additional background on Fireman's Park and how this 13.1 acquisition will compliment future park developments. The 13.1 acre property includes important wetlands and frontage along Badger Mill Creek.

Smith concluded that all three of the grant applications will come before the Commission again as resolutions to consider for approval of grant funds.

Marsh provided an overview of the purpose of the meeting, which is to get feedback on a possible policy change that would prohibit dogs from a critical habitat area on County lands at Pheasant Branch Conservancy.

2. Parks & Trails Unite Festival

Marsh presented a poster for the Parks and Trails Unite Festival. The Festival is being held on June 2, 2018 from 10 am -7:00 pm and will be held along the Lake Waubesa shoreline at Lake Farm and McDaniel Parks. The event is a partnership between Dane County, Friends of Dane County Parks, the Friends of Capital Springs Recreation Area and United Madison. The celebration is to bridge barriers and unite communities through our parks and trails. The festival will include live concerts at both McDaniel and Lake Farm Parks, food and beverages, educational outreach and many activities tied to both land and water. This free event supports the Parks Endowment and expanded opportunities for the parks volunteer program. Many volunteers will be needed to support the event.
