Fitchburg Critical Incident Team Update

Hospitals discussed their efforts to assist. Meier will follow up with Fitchburg to see what their continued needs are and connect them with the appropriate contacts at each hospital. Lisa with Stoughton spoke of the need to discuss mental health benefits available thru workers comp. She and her human resources department worked closely with their insurance carrier to now have a policy in place to offer 6 treatments at a minimum.
