## 1. FAMILY CARE TRANSITION UPDATE Jennifer Fischer, Manager, Aging and Disability Resource Center of Dane County

FISCHER provided a summary of the Family Care transition. All existing Waiver program

participants transferred to a new program by May 1st, 2018 except for two individuals. These

two individuals are familiar to the ADRC and they are monitoring their status to assist as needed

when they are eligible to enroll.

Breakdown of enrollments by Family Care Program type:

46% IRIS

46% Family Care

7% Partnership

ADRC is now focused on removing names from what had been the Long Term Care Services

waiting list based on a formula provided to them by the State which allows them to take approximately 12 individuals off of the waiting list each month for the next three years until

entitlement is met in 2021.

The LTS Committee publicly applauds the efforts of the ADRC and Dane County Department

of Human Services in transitioning individuals into Family Care, Partnership and IRIS programs.
