Proposed Draft Fee Increase for 2019

All other permit fees are proposed to remain unchanged in 2019. LUNNEY and Marsh explained to the Commission how revenues collected from park fees help offset operation and maintenance costs.

F. Presentations - None**G. Reports to Committee****1. Brief History of Prairie Moraine County Park - Jesse Charles, Verona Historical Society**

Charles provided a summary of historic use of Prairie Moraine County Park by the county prior to it being transferred to the Dane County Park Commission in 1993. Charles provided recounts of oral histories, Dane County records, and newspaper articles that indicated two individuals with leprosy were relocated to live in a small cabin somewhere on the park property between 1896 and 1902. Charles believes the original cabin site may have been located through an investigative effort involving the Wisconsin Historical Society, parks staff, and the newly formed friends group.

2. Friends of Prairie Moraine

Tooney informed the Commission of the status of the Friends of Prairie Moraine which was recently formed in 2017. This group works extensively with the parks naturalist and the Ice Age Trail Alliance, primarily on invasive species removal and restoration of remnant prairie landscapes. LUNNEY recommended Tooney follow-up with Marsh on continuing to explore additional capacity building opportunities that are available to Dane County Parks friends groups.

3. Ice Age National Scenic Trail - Ice Age Trail Alliance

Lonsdorf provided the Commission with a history of how the Ice Age National Scenic Trail was established at Prairie Moraine County Park. He went on to describe the geologic significance of geologic features found at the park including the terminal moraine and St. Peters sandstone rock outcrops. Lonsdorf also expanded on the large scale prairie restoration efforts that have been made possible through a successful partnership between the Ice Age Trail Alliance, the Friends, and Operation Fresh Start volunteers.

4. Indian & Mud Lake Restorations - Update on DNR & LWRD Proposed Steps

Marsh provided an update on carp removal efforts that will be undertaken by the Wisconsin DNR on Indian Lake in September. Land and Water Staff will assist with the project. Staff will continue to keep the Commission updated and provide additional public information in August on the status of the lake restoration project. The Wisconsin DNR is also assessing and monitoring the carp removal efforts on Mud Lake in the Town of Roxbury to determine if further restoration work will be required.
