1. Executive Summary final review (Koenig)

Committee reviewed an updated and re-formatted version of the 2018 Executive Summary prepared by Maniaci reflecting changes recommended at the last meeting. Several additional changes will be made including:

- Include all demographic groups in a table format. Add a "Definition of Terms" page to the end to include pansexual, transgender, Latinx, etc.
- Take out use of word "significant" and any other qualifying language.
- Include data points for multi-race identified students (Koenig will prepare)
- Review for consistency of punctuation and use of descriptive language
- · Much of the introductory language was removed. What remains is referenced.

Next steps include: 1) committee members sending grammatical suggestions to staff for input integration into one document with changes; 2) This document will be sent to Maniaci for final revisions; 3) Final version will be proof read by Brey and sent on to division administrators for review and approval. 4) Presentation of final Executive Summary to the Youth Commission on 9/6.
