D. Presentations**E. Reports to Committee**

1. Legislative Update/Announcements:

- Murray informed members that the October agenda will include a presentation with guest speakers on the intersection between immigration policies and sensitive crimes. The October agenda may also include a final report on the Court Watch. The November agenda will include a budget discussion with County Executive Parisi and Director Lynn Green. A new Commission Chair will be elected in January.
- There are two new Commission positions created by Ordinance Amendment. Murray requested that members email him contact information of candidates that would be a good fit for these new positions. He will contact them and discuss it with them.
- McCarville distributed a Schedule for Review of 2019 Dane County Budget (attached) and discussed the process.
- There was discussion about COSC LTE funds which is budgeted the same as last year.
- Murray requested CCR 's submit their 2018 reports to him by the end of October along with 2019 LTE hour budget requests.
- Howe submitted the grant for violence against women regional prosecutor that Dane County has had for the last 3 years. DOJ has indicated that we will be able to continue this position.
- Sathasivam noted RCC's Java Jive is Sunday, September 23, 9:00am – 12:30pm, at the Brink Lounge, 701 E. Washington Ave, Madison, \$40 in advance/\$45 at the door.
- Kato noted Rhumba 4 Rainbow is Friday, September 21, 7:00 pm- Midnight, Varsity Hall at Union South, Madison.
- Ginsburg reported that Safe Harbor is moving a week from tomorrow to 2445 Darwin Road, Suite 20, Madison. Interviews will be done at the sheriffs office next week. Emails and phone numbers will remain the same. There will be an open house on November 7.
- McCarville reported that the Coroner has moved into the new building and may be adding another medical examiner. Opioid related deaths are being documented more with more tests being done.

2. CCR Updates:

- Child Abuse & Neglect: Kato reported that many more members have become involved in the child abuse task force. The trauma informed advisory council will have an all-day summit on November 16.

- Intellectual Disabilities: Pomije reported had two meetings and they are establishing a mission statement and goals. They had presentations from the TIES program and ARC Counseling. Managed care organizations will begin presenting next month.

- Domestic Violence: Scarr commented that she attended DV CCR retreat and it was excellent. Barry provided the following written update:

Howe reported that the Legal Issues Subcommittee will present at the October DVCCR meeting. The court watch is in the 2nd or 3rd round of 17 judges and will put together trends discovered. We are hoping to identify gaps and work on training. The Sheriff Department will present at Legal Issues tomorrow on Preserve the Peace.

- Elder Abuse: Scarr reported that the EACCR had an AARP presentation on how to talk to older folks about driver safety and when to stop driving. The DV in Later Life Conference is October 5, 8-2:30, at Institutes for Discovery, UW-Madison. The Triad Conference is September 28, 2018, 8:00 am - 3:00 pm., "Keys to a Safer Life" - Learning how to keep ourselves and those we care about safe, American Family Insurance Training Center. Scarr also provided a Financial Abuse Specialist Team update.

- Sexual Assault: Sathasivam reported on the SACCR. Miyasaki reported on the Committee on Commercial Sexual Exploitation of Children (CSEC). The systemic change diverting girls from juvenile justice to CPS is being used more. The multi faith coalition against child sex trafficking has become member of the CCR. A public

awareness campaign to raise consciousness among the community is being planned.
