# EXECUTIVE COMMITTEE AMENDMENTS TO THE PROPOSED 2019 **OPERATING BUDGET**

The committee first reviewed all the amendments, and then voted on each of them. Chair Corrigan explained each of the Board Office amendments.

EXEC-O-01 - conference and training; motion to recommend approval by Bollig/Ratcliff, carried on a voice vote 6-0.

EXEC-O-02 - various line item increases to implement inclusive engagement; motion to recommend approval Jones/Bayrd.

Motion to amend to add the Wegleitner proposal to increase video services by \$10,000 and to add the Danner proposal to increase outreach services - POS by \$10,000 to this amendment, with the specific language about intent added to the motion and justification.

Motion to amend carried on a voice vote, (6-0). EXEC-O-02, as amended, was recommended for approval on a voice vote (6-0).

EXEC-O-03 - policy analyst with focus on engagement; motion to recommend approval Young/Bollig; carried on a voice vote (6-0).

EXEC-O-04 - increase sustainability coordinator position from .75 FTE to 1.0 FTE as of 10/1/19; motion to recommend approval Bayrd/Ratcliff; carried on a voice vote (6-0).

EXEC-O-05 - Clerk I-II beginning mid-year; motion to recommend approval Bollig/Jones; carried on a voice vote (6-0).

EXEC-O-06 - Funding for Office for Equity and Diversion to educate individuals on license reinstatement and record expungment. Several people addressed the committee in support.

Supervisor Stubbs spoke of barriers to employment.

Vicky Selkowe, Legal Action of Wisconsin, indicated the funding would allow the organization to launch the program.

Dr. Ruben Anthony, Urban League of Greater Madison, spoke of the enormous demand for educating individuals regardig how to obtain reinstatement or expungement, and the importance for housing and employment.

Alex Lodge, who is an attorney, spoke of his work on this effort and the scope of the need.

Edward Lee, Urban League of Greater Madison, registered in support.

Motion by Bayrd/Young to recommend approval; motion carried on a voice vote (6-0).

EXEC-O-07 - increase funding for video services to broadcast two committee meetings per month.

Kathleen Fullin, representing the League of Women Voters, registered in support of adding funds to broadcast meeings.

This amendment was incorporated into EXEC-O-02.

EXEC-O-08 - increase funding for outreach services - POS, specifically for juvenile justice engagement. This amendment was incorporated into EXEC-O-02.

Chair Corrigan indicated that Supv. Kuhn had three amendments which were not posted in time for committee consideration. Supv. Kuhn addressed the committee. One amendment added funding for Spanish language ballots in the County Clerk's Office. Another, with Supv. Nguyen-Hilfiger as the primary sponsor, requires county departments to provide their equity plans to the Office for Equity and Inclusion (OEI) by February 1, 2019. The third requires OEI to develop training plans and provides \$3,000 in funding.

Motion by Ratcliff/Bayrd to move these three amendments to Personnel and Finance with no recommendation. Motion carried by voice vote, (6-0).
