  - 1. 2019 County Executive's Budget

Hicklin gave an overview of the proposed LWRD budget for 2019.

#### 2. Multiuse Trail Projects

Sara Rigelman gave the commission an update on the status of the PARC and Ride grant applications and stated more information would be available at an upcoming meeting.

Chris James, Senior Landscape Architect, provided an overview of the work that is being done on a number of large multiuse trail projects around Dane County including:

- •Glacial Drumlin Trail working to establish trail between Madison and Cottage Grove. More specifically the current project creates a trail that links trails on the West of the Interstate to CTH AB to the East. Currently working on one key acquisition along with the plans and specifications prior to beginning development.
- •Lower Yahara River Trail Phase II is a trail section from Fish Camp County Park across Door Creek wetlands over to Lake Kegonsa State Park. This section is the County's second phase of the trail development from SE Dane County to the City of Madison. Work will commence soon on the development of plans and specifications with trail construction anticipated to commence by 2021.
- •North Mendota Trail Waunakee to Middleton and Madison. The project is moving forward. Work will begin soon along County M and through the State Park. Dane County is helping to facilitate this trail project with other partners doing the majority of the work.
- •Walking Iron Trail (Mazomanie to Sauk City) There is a great deal of discussion and ideas being shared on how to secure a Trail Corridor between Mazomanie and Sauk City. Dane and Sauk Counties will be completing an analysis regarding the feasibility of developing a recreational bridge across the Wisconsin River to support bike/ped/snowmobile uses. The county is also working with partners to explore other trail route options.
- •Black Earth Creek Trail (formerly known as the Good Neighbor Trail)- Dane County is assisting local units of government and partner groups on potential trail routes. There are a number of constraints within the Black Earth Creek Corridor including very narrow sections with steep topography, the creek, active railroad line and STH 14. Ultimately, there may be sections of this trail that need to wait until the final planning and development work is completed on STH 14.

#### H. Announcements

RIPP provided an update on the Friends of Schumacher farm Harvest Fest and the Friends of Indian Lake Park Fall Trail Run.

Chair LUNNEY gave an update on the Capital Springs Harvest Moon Event and the recognition of the Lewis Nine Springs E-Way by the American Planning Association Wisconsin Chapter as a "Wisconsin Great Place."

Rigelman stated that the PARC Grant Applications were due on October 1st and are now being evaluated by staff to provided recommendations.

Marsh informed the Commission that LWRD staff were assisting the WDNR Fisheries on a State Restoration Project for Indian Lake on October 17, 2018. The DNR will be treating the lake to remove the carp population and bring the lake back into balance for improved wildlife and fish habitat along with recreational uses.
