D. Budget Discussion and Amendments

1. 2019 **ACT-166** PUBLIC PROTECTION & JUDICIARY COMMITTEE AMENDMENTS TO THE PROPOSED 2020 OPERATING BUDGET

PP&J-O-1: Sup. Rusk presented the amendment, and offered a modification to it. The modification would add another sentence to the language of the motion:

It is recommended that the position description clearly delineate that the SW position will work for the PRP attorneys.

PP&J-O-4: Sup. Kiefer presented the amendment, and explained the importance of paying the state bar dues for the attorneys. Committee members discussed the benefits of paying the state bar dues for the staff attorneys.

PP&J-O-5: Sup. Kiefer presented the amendment, and explained why there won't be a budget impact if paid holidays were granted to the staff attorneys. Supervisor Danner expressed concerns about how staff attorneys were not granted paid holidays prior to PP&J O-5. Sup. Bayrd questioned whether PP&J O-5 should be better handled by the members of Personnel & Finance Committee.

PP&J-O-7: Sup. Kiefer presented the amendment, and explained why there is a need for a deputy to be present during County Board meetings. Sup. McCarville questioned why a deputy is needed for Board meetings, but not committee meetings. Sup. Kiefer explained the reasons why PP&J O-7 was limited to just the Board meetings. Sup. Nguyen-Hilfiger asked whether other municipalities used sworn law enforcement officers to provide security for their legislative sessions. Sup. Kiefer indicated that the State Legislature used sworn officers. Sup. Bayrd, Krause, Danner and Rusk expressed concerns about the impact to the public of having a sworn officer at the meeting. Sup. Kiefer clarified what sort of circumstances the deputy would be expected to handle.

PP&J-O-2 & O-3: Sup. Bayrd presented both amendments, and informed the Committee that the DA would prioritize O-2 before O-3. Sup. Danner asked if there was a distinction between the two positions in O-2 and O-3. Sup. Bayrd explained that O-2 would handle the increase of volume in juvenile cases, while O-3 would focus on restorative justice approaches. Sup. Rusk asked DA Ozanne whether either position would address the racial disparities present in the jail. DA Ozanne explained how each position would fit into the current criminal justice system, and how they may assist with prevention and education efforts. Sup. Schwellenbach asked about specific examples of what O-3 would do for restorative justice efforts. A. Brown provided a number of examples of such efforts. The Committee members discussed a number of different funding options.

PP&J-O-6: Sup. Bayrd presented the amendment, and explained why the elimination of home detention fees would have very little impact. J. Bauman explained the fee, and expressed support for the motion.

PP&J-O-8: Sup. Stubbs and DA Ozanne presented the amendment. Sup. Stubbs explained the history behind the County's restorative justice efforts, and DA Ozanne informed the committee of his attempts to seek assistance and funding from the State. Sup. Rusk asked whether the selection of a consultant would be subject to an RFP. Sup. Stubbs agreed that it would. Sup. Schwellenbach asked DA Ozanne about what sort of timeline would be reasonable for the building of a community justice center. Sup. Stubbs and DA Ozanne explained potential timelines. Sup. Bayrd asked whether

inmates from the jail and prisons could take advantage of the center. DA Ozanne stated it would.
