1. Report of Noise Subcommittee

Vice-Chair PROBASCO deferred to Supervisor Rusk, Chair of the Noise Subcommittee.

Supervisor RUSK reported that the Noise Subcommittee provides opportunity for the public to have its noise-related concerns addressed. He added that the National Guard attends as a guest and that Airport Director Jones did a great job of asking everyone in attendance at the noise meeting to respect and listen to one another. Rusk added that Lowell Wright, the Airport's Noise Abatement Officer, does a good job presenting the noise complaints at the meetings. Discussion ensued including comments that the Airport's Noise Abatement program is voluntary in compliance with the Federal Aviation Administration (FAA) requirements. The Airport will provide on its website the Air National Guard's schedule for the public and other interested parties.

2. Report of Art Subcommittee

Vice-Chair Probasco, who is also a member of the Art Subcommittee reported that Bill White, Chair of the Art Subcommittee does a great job, and has for awhile. The ideas and art court implementation have proven unique to Dane County Regional Airport. It is one of few airports that allow for the public to see a gallery pre-security screening. PROBASCO reported that the Art Subcommittee approved 2 upcoming displays in the Airport's art court including The Center for Railroad Photography & Art and a juried show by Wisconson Visual Arts with the Theme "Art is in the Air."

1. Activity Report

Vice-Chair Probasco deferred to Airport Director Jones.

Jones reported that the Airport's growth for September month-over-month from last year, is up a robust 12.3%. Year-to-date realized very positive growth of 11%. The Airport's activity is higher than the national average of 6-7%. The concessionaires are happy to report increased activity and airlines are consistently adding additional capacity and flights. Jones reported that overall the positive growth is on par to continue as new direct flights are beginning now and in the coming months.

2. Property Acquisitions

Vice-Chair Probasco deferred to Airport Deputy Director Jensen who reported on two potential properties that the Airport is interested in purchasing for future long-term growth. Jensen and other Airport Staff will be coordinating the potential purchases with the county and state entities who oversee such acquisitions. Discussion ensued and there was a brief question and answer period. Overall, the Airport is in good position to consider the land acquisitions. The Vice-Chair thanked Deputy Airport Director Jensen for his presentation on the parcels.

3. Holiday Music Program

The Airport's Holiday music program, coordinated by Brent Kyzer-McHenry, the Airport's Marketing and Communications Director will be held December 14-23, including a "community sing-a-long" on Sunday, December 16th. Many schools and adult groups perform during the Program.
