- Food for Thought Initiative Jim Green, Director of East High Food Pantry and Joel Wish provided an introduction adn overview of the Food for Thought Initiative. Food pantries are now available at East High, Sandburg, Mendota and Cherokee Heights schools. Priority is given to high need schools and plans are to open a new pantry each year.
- Partner Share Report Carrie Sedlak, FairShare CSA Coalition Program Manager, provided a report on the 2018 Partner Share Program. The funding from the County allowed the program to serve an additional 23% in 2017 and in 2018 the program expanded to 93 shares including 628 people in Dane County.

- Work Team Reports
- 1. Food Waste & Recovery: RITT provided an update. The guide is ready and the website will be done by the end of the year. Magnets are currently being made and pamphlets and brochures will be developed in early 2019. Food Waste Convocation plans are underway and will be held in March of 2019. Progress is being made on the No Thank You tables. An SoP has been developed and hoping to go to the MMSD Board of Education in January.
- 2. Equity & Access: WARNER shared an update on group discussion from the past two meetings and plans for the upcoming meeting.
- 3. Urban Ag: Reistad provided an overview of current discussions including city plans for the Voigt Farm and community garden land donations.
- 4. Budget: CHENOWETH shared that the 2019 County budget has been approved. The half time food systems coordinator position and the increased funding (\$5000) for food projects for the PIE grants were included.
- Madison Food Policy Council Reistad shared that the city has identified two finalists for the feasibility study for the cross docking facility. They will be presenting on Dec 5th from 9-11 am. He also shared that Luna's Grocery is set to open on Dec 15th.

- Dane County UW-Extension Carrie Edgar shared that funding is included in the 2019 budget to fully fund the Dairy & Livestock Educator as well as the half time Food Systems educator position. The development of the position descriptions is in process and hoping to hire shortly after the first of the year.
