Christine Haag 2007 to 2018 - currently a Department of Natural Resource Program Manager for the Brownfields and Outreach Section, formerly the Vice President of Real Estate for TFW Ventures, Madison and Executive Director, Ice Age Park and Trail Foundation – now known as the Ice Age Alliance, Inc.

Mary Schlaefer 2010-2018 – currently Executive Director of Wisconsin Energy Conservation Corp (WECC) – Madison nonprofit that provides efficiency and renewable energy planning, design and implementation services throughout the United States, served as Executive Assistant and Deputy Secretary of the Wisconsin Department of Natural Resources. Mary was responsible for leading the development of the department's budget, overseeing and approving land acquisitions, and general oversight for all public lands and resource management including all hunting and fishing regulations.

George Gillis 2016-2018 – served as a County Board Supervisor, is the Executive Director of the Democratic Party of Wisconsin

PARC & RIDE GRANT APPLICATIONS 2018

Rigelman provided the Park Commission an overview of the PARC and Ride Grant Program for 2018. The program is funded at \$500,000. There were seven grant applications submitted for a total request of \$803,778. Staff utilized the approved grant criteria to evaluate the applications. The criteria included:

- 1) provides new trail linkage
- 2) located along a river or lakeshore
- 3) anticipated heavy trail use
- 4) connects to low income neighborhoods
- 5) compliments surrounding development
- 6) identified in multiple plans
- 7) secured funding
- 8) project clarity
- 9) application complete

An additional criteria that was used was the number of grants that entities had received in the past. The idea was to spur more communities to work on developing trail connections.

The applications that staff recommended for funding were:

- Village of Cambridge \$209,250
- •Village of Cottage Grove \$182,500
- Village of Windsor \$81,600

There would be a remaining balance of \$26,650.

The Village of Shorewood Hills project was not recommended by staff for funding this time since they had already received two previous grants.

There were 15 guests in attendance to support the Village of Cambridge Grant request for the trail connection from Cambridge to Glacial Drumlin State Trail. A number of people spoke in favor of the regional trail project.
