A motion was made by ERICKSON, seconded by WELLS, that RITT and PORTER serve as Co-Chairs of the Yahara Chain of Lakes - Lake Levels Task Force. The motion carried by a voice vote: 12/0

E. Public Comment

Janet Battista asked if lowering Lake Mendota would have a beneficial effect on Cherokee Marsh, which has lost wetland from flooding, and if the outcomes of the scenarios would be different if the models were run against different years.

Dan Schultz noted that there are limited management options when the only tool is operation of the Tenney dam. He encouraged a solution that addresses the issue of flow through the system and he congratulated the technical work group on their report.

Brett Hulsey noted that the report misses the bigger picture of what's happening in 217 square miles of the watershed and encouraged solutions that include water storage on agricultural properties in the northern portion of the watershed. He mentioned the "agri-drain" tool that may help assess and identify storage areas.

Charles Dykman, noted the possibility of pumping to Keenan's Creek, which may be a shorter distance than pumping to Badger Mill Creek and therefore less expensive.
