E. Public Comment

- Joy Zedler – Spoke in opposition and asked that scenario six, pumping, be rejected and that upstream approaches be utilized.
- Donald Sanford – Spoke in support and noted that our community has struggled with options for addressing high water in the Lower Yahara for decades. We have better data and science than ever before, and this is the time to do something.
- Eric Katte – Noted that he disagrees with comments that the adaptation scenarios are outliers, that water can't leave the system fast enough, and that we need to be able to get water out of the system faster. He wondered if a bank analogy would be helpful in understanding the system.
- Charles Dykman – Spoke in support and noted his appreciation of a science-driven solution. He's become a fan of the pumping scenario and he doesn't understand the concern that pumping may negatively impact wetlands.
- Steven Schooler – Spoke in opposition and noted the following: 1. Pumping is not a good solution for 2019, 2. Lake Mendota should be managed at a lower level, 3. Everyone should review the 1979 WDNR orders, 4. Lowering Mendota is not outside of historic norms and 5. The pumping volume is seven times greater than the existing MMSD pumping.
- Pete Karnes – Wondered if other universities in the state have been consulted and noted that Madison and Dane County will look like fools if a Lake Delton event strikes. He proposed the solution of laying pipe and pumps to the Wisconsin River that are only activated if certain levels are reached.
- Ed Minihan – Representing the Town of Dunn, noted that the Town of Dunn has built six detention basins, has more riparian area than any other municipality, and that the area identified for pumping is the cleanest in the system. He believes pumping through the Waubesa wetlands should be off the table. He proposed using existing MMSD pipes for pumping. He noted that closed basins in the northern part of the watershed must be addressed.
- Nick Miller – Representing The Nature Conservancy, suggested that nature, specifically wetlands, may be part of the solution for flood abatement along with other ecosystem services. Over half of wetlands have been lost in the watershed, along with their services. Remaining wetlands must be protected and lost wetlands should be restored. He noted the "wetlands by design" tool, which may be helpful.
- Ben Kollenbroich – Representing the Town of Dunn, noted that several of the properties that may be impacted by the pumping are encumbered by local, state and federal easements or other protected lands and that there is a potential for contamination in dredge materials. He proposed that US 51 corridor may be an option, particularly during reconstruction.
