1.Food Waste & Recovery– Ritt provided an update. The Food Waste Business Convocation will be held on March 19th.

2.Equity & Access– Warner provided a brief update. PIE grants are due March 1st. Claire Mance is working on recruiting a 3rd reviewer for the applications.

3.Urban Ag– von Huene shared that the last meeting was cancelled. Reistad shared that the work team is very focused on City projects currently including water access issues for community gardens.

-Madison Food Policy Council – George Reistad provided an update on the Double Dollars program and a reminder that the SEED grants are closing on March 1st.

-Dane County UW-Extension – Carrie Edgar shared that the process is moving forward on the hiring process for the Community Food Systems Coordinator. There should be someone on board by next month. Edgar also shared that Extension is in the process of hiring a Dairy & Livestock Educator. Edgar provided an update on the Cultivating Dane proposal. Edgar passed out the action plan for 2016 and 2017 and requested the Council consider a process to update the plan this Spring. She also reminded members that three citizen member terms will end in April 2019.
