C. Presentations and Possible Action

1. Alliant Energy Center Phase 1 Preliminary Design Presentation

Introduction of Strang and consultants:

Matt Long (project manager) John Slack and Don Defthlys (Perkins & Will)

Did branding exercise - versatile, creative, innovative

J. Slack and D. Defthlys presented the preliminary designs for phase 1 of the AEC redevelopment. Defthlys noted the differences including: moving the arena closer, adding a column to allow for a large banquet room on the second floor. J. Slack noted that the design of the facility is agrarian, which they learned created an authentic feel through their branding exercise.

D. Defthyls noted that they added an additional space for storage

D. Vrinberg – Convention Center expert is working with Strang

Preliminary renderings of building were presented

D. Ripp inquired about the drainage from the roof. The presenters noted there is a water collection system on the roof.

J. Slack noted that they've had a lot of conversations around stormwater improvements – for this there will be a line item in the estimate for stormwater, but no details until the building moves further. Noted they will need to meet City of Madison standards.

S. Carter inquired about the continuity of stormwater management with the rest of the campus. The presenters noted they are keeping that in mind.

T. Berceau encouraged looking at different options for a green roof

D. Defthlys presented the preliminary plan for the arena

T. DeChant inquired if the club space presented is tempered – D. Defthlys noted that it is

Discussion about the flexibility of the space ensued

D. Defthlys note that they advise their clients not to put something in that they are going to potentially need to rip out at some point

T. DeChant – inquired about the capacity to put in electric charging stations. The presenters noted they have included a few.

S. Stubbs inquired about how much sound is being blocked with designs – the impact on the neighborhoods. *D.* Defthlys noted that pulling the road in created a bigger buffer between the neighborhood and the campus.

D. Ripp inquired about how much parking will be lost – the presenters responded in this phase, the lost parking was captured

S. Corrigan inquired about next steps

M. Clarke noted that Strang is on retainer for the entire project

Schematics cost about \$450,000 which would be more detail and more consultants

Strang has sent designs to cost estimators, which will have it done in October
