#### G. Reports to Commission

#### 1. Activity Report

Director Jones reported on activity. Activity continues to be very positive. She explained that even though seasonal direct flights ended April 6, there was no real impact on activity. Year-over-year for the month of April, enplanements remained steady at 19.1%. Overall for the year activity remains high at 17.8 % growth. The rapid airport growth is causing "growing pains" for Transportation Security Authority (TSA) resulting in longer wait lines, primarily in the morning rush. Additional check lines may be added in the future. The Airport, Airlines and other tenants are experiencing the growing pains, as well.

In addition, the parking ramp has occasionally been at capacity in their "covered" parking which may indicate potential expansion. Expansion is under consideration and consultants will be meeting with the Airport staff to address different options.

On the other hand, Jones added, due to the growth, the Airport's concessionaires are realizing record days for sales.

Discussion ensued and there was a short question and answer period. The feedback from the commission was very positive.

2. Briefing on Summer Airfield Construction

Jones introduced Michael Kirchner, the Airport's engineer and Director of Planning and Development. Kirchner referred to two exhibits pointing out Taxiway "M" to be completed this summer and Taxiway "J" which will be reconstructed to 75 feet wide from 50 feet and from asphalt to concrete. He added that the East Side Road relocation would free up space for development on the East side creating room for 2 additional corporate, large hangars.

There were several questions and answers and some discussion ensued. Kirchner noted that a more detailed slide presentation relevant to terminal expansion would be forthcoming at a future meeting.

3. Airport's 80th Anniversary Update

June 23, 2019 marks the day for celebration of the Airport's 80th Anniversary! Jones deferred to Deputy Director Jensen to highlight the East Ramp Activities that will be happening. He explained there will be bus tours of the airfield including an opportunity for visitors to exit the tour bus and visit a vintage building, the "Old Stone Hangar" where there will be music, food and beverages available. In addition there will be a static display of several aircraft, both military and general aviation, fire-fighting equipment and Airport snow removal equipment. Visitors will get back on the bus and near the completion of the tour be driven through the snow removal equipment building. The tour ends back at the terminal where Jones added that there will be food and beverages; kids games; historical exhibits; and a career fair all culminating in an unveiling by County Executive Parisi of an historical "beacon," followed by a concert by "Voice's" Chris Kroeze. Everyone expressed optimism about the turnout for the event. Jones added that there were still volunteer opportunities available and that it took many staff, interns and others to coordinate the effort.

Jones added that the next few Airport Commission meetings will have several presentations including the proposed 2020 Airport Budget.

Supervisor RUSK asked about the recent night flying by the Air National Guard's (ANG) F16s. Jones replied that, in fact, there is a link on the Airport's website to the Guard's site explaining the night flying schedule.

A motion was made by Supervisor BOLLIG, seconded by Cmsnr. ARMSTRONG, to adjourn. Motion carried by a voice vote. (7-0) The meeting adjourned at 6:07pm.
