 - Token Creek Master Plan Review Chris James, Dane County Parks Senior Landscape Architect

James provided an overview of the 2011 Token Creek Park and Natural Resource Area Master Plan recommendations including proposed entrance relocation, an expanded campground, and safety improvements. Token Creek is the only DNR designated cold water trout stream in Dane County and provides more than half of the entire base flow of water to Lake Mendota.

2. Token Creek Wetland Restoration Project - Sara Rigelman, Dane County Park Property Planner

Rigelman provided an overview of the wildlife habitat and wetland restoration project that is planned for Token Creek County Park. In partnership with USFWS, wetland drainage ditches will be removed by using water control structures that will restore a more natural hydrology and improve the water quality of Token Creek which is the single largest source of water to Lake Mendota flowing through Cherokee Marsh. The habitat project also entails a 10-acre prairie restoration. Grants from USFWS and DNR's Waterfowl Stamp program will help fund the project.

3. Token Creek Sediment Removal & Restoration Project - John Reimer, Land & Water Resources Assistant Director

Reimer provided an update for sediment removal and restoration work for Token Creek that will begin in late summer 2019. The project is intended to improve water quality by removing phosphorus laden sediment and improve fish (trout) habitat by adding large boulders, root wads, and shoreline protection practices.
