D. Presentations

1. Assistance for Those Who Experienced Homelessness Due to Flooding – Kim Mindham, Project Recovery

Project Recovery is a FEMA funded community-based program providing outreach and crisis counseling to communities impacted by severe storms and flooding that occurred in the summer of 2018. While canvassing to identify those affected and are in need of assistance, program staff encountered people who became homeless due to flooding in Dane County and would like to identify better ways to reach people who are displaced and connect them to resources.

Committee members provided suggestions on whom staff can connect with, including MMSD's Transitional Education Program (TEP) program and the State of Wisconsin Interagency Council on Homelessness staff.

Wegleitner acknowledged the need for better coordinated communication about resources during extreme weather for people experiencing homelessness and expressed the concern that local governments are not addressing air quality and mold issues in rental properties while tenant services are limited.

3. Dane CoC System Performance Evaluation and Need Projection – Sarah Lim, City of Madison Community Development Division

Committee members discussed the barriers individuals and families experience in obtaining housing in Dane County including lack of affordable housing, affordable child care, and inadequate employment income.

Wegleitner noted that projection appears incomplete as it does not list other permanent housing interventions (e.g. long term rent subsidy for people who are not considered chronically homeless but have disabilities).
