#### C. Discussion Items

Infection Control Resource Handbook - Lohmeier

*Committee members will be given until July 15th to look for last minute changes to the handbook. Grammatical errors and changes to verbiage on pages 6 and 7 will be made by end of the month. One copy will be printed for each EMS agency, each infection control agent at the EMS agencies, each hospital, and each hospital EMS breakroom.*

## 2020 Protocols - Meier

*Meier put out survey to get feedback from agencies about changes to be made to Protocol book. Two "town hall" sessions will be hosted at Madison College for EMS personnel to give input on changes. These will be followed up by three work group meetings to discuss changes to Protocol book.*

## Cardiac Arrest QA Update - Meier

*Meier and Kronenfeld got together to review cardiac arrest incident information. The goal is to connect all responders of a case by sending out technical data about response efforts via email for agencies to distribute and discuss with their first responders. All cardiac arrests reported will have data sent back to the agency; this should be ready to implement within a couple months. They will also be working with 911 to ensure calls are coded correctly to fast track CPR in cases where it is needed.*

## Data Exchange - Meier

*Committee discussed other possible software options for better, more streamlined way for EMS to access patient health records pre-hospital. Meier was advised at medical conference in Fon du Lac to have the correct IT personnel at a hospital get in contact with Epic to discuss options to create this platform. Carbon reported that Madison Fire Department met with representatives from Julota, a data exchange company able to provide a platform for comprehensive information. A work group will be created outside of committee to review possible options.*
