1. Friends of McCarthy Report

Dean Kalmerton and Karen Bailey from the friends group provided an overview of activities and involvement at McCarthy Youth and Conservation Park including prairie restorations, special events, and working with the Ho-Chunk Nation on an interpretive trail throughout the park. Chris James provided additional background on the history of planning for the park, including the McCarthy's original land donation of 180 acres in 1974 and their desire to create a park where kids from the city could go and learn about nature.

2. McCarthy Restoration Projects

Dean Kalmerton discussed a variety of restoration projects the friends group has been working on with Parks staff and Operation Fresh Start, including removal of invasive species in woodland areas, prairie restoration, and wetland scrapes.

3. McCarthy Capital Projects

Chris James described future improvements planned for the main parking area including a new shelter, picnic area, playground, and drinking water. A professional consultant is expected to be hired in late 2019, with planning anticipated to be completed by spring 2020. If funding allows, development may occur in 2021.
