# MCI Trailers - Stacy Hanson

Hanson updated committee on progress of organizing and updating MCI trailers. The trailer located at Blooming Grove is almost complete. Hanson to add information for hitch requirements, full inventory list, and SALT triage bags. Further considerations will be made regarding what other materials should be included with the remaining funds. Dostalek asked if the county will fund cost of restocking the trailers or if it will be billed out to the agencies that use them. Meier said that conversation may be revisited in the future once the trailers start becoming regularly utilized by agencies for pre-planned events. Meier to assign an LTE to provide general maintenance to all trailers.

#### Guidance Document - Wunsch

Wunsch updated committee on the Active Threat/Critical Incident Response Guidance document that is being worked on among several partners. Effort is being made to add universal comunication zones that all response agencies in the county will have programmed into their equipment for use. The goal is to have all agencies approve the plan by January. Meier to send draft to chiefs.

#### MCI Plan - Meier

Committee members received copies of the Mass Casualty Incident plan and will review sections of it at upcoming meetings. This is the document the Dane County EMS Protocol book refers first responders to in the case of a mass casualty inicident. Ziegler shared information about an MCI class being offered by Green County in the middle of November; Ziegler to follow up on getting some members registered if openings still exist.
