Dane County retiree Dee Heller presented on the History of Dane County Healthcare Facilities (1852-present).

E. Reports to Board

1. 2021 Budget Priorities

AAA Manager Cheryl Batterman provided updates of the requested AAA budget increases for Case Management, Nutrition Site Management, and Cultural Diversity. Additional funding for the Cultural Diversity Program was included in County Executive Parisi's budget proposal. Health & Human Needs Committee supported an amendment to include additional funding for the Nutrition Site Management program. The next step is for the Personal & Finance Committee to support and forward to the full County Board for approval.

2. State and Federal Report

Laura Langer of the Wisconsin Office on Aging announced Sonya Lindquist is the new Dane County Program Coordinator for the State's Senior Community Services Employment Program (SCSEP). The program has participants on temporary paid sick leave due to the pandemic. The Retired Senior Volunteer Program (RSVP) and Foster Grandparent Program (FGP) state applications will be released soon. Bureau of Aging and Disability Resources (BADR) staff are urging counties to revisit their emergency plans. With COVID-19 and winter weather, it is extremely important to have back up plans—especially for nutrition sites.

3. Board Member Reports

a. AAA Access Committee

FLAD shared the Committee had annual presentations concerning the Volunteer Guardianship/Rep Payee programs and Adult Protective Services. COVID-19 is making it difficult to retain volunteers and provide non-contact services for older adults. A concerted effort is being made to contact older adults as social isolation and loneliness are a serious concern.

b. AAA Legislative/Adocacy Committee

BUNCK reported the 2020 US Census is done and over 70% of the nation submitted information online. Many of the census marketing strategies created by Dane County AAA was replicated in other Wisconsin counties.

4. Chair & Staff Reports

BATTERMAN and AAA Aging Program Specialist Angela VELASQUEZ discussed emergency plans AAA has in place with shelf stable meals if COVID-19 continues to spread or with winter approaching. Several aging networks (AAA, ADAW, ADRC, APS, PHMDC, and VA) are collaborating on two potential projects that address social isolation and loneliness. Details will be shared when plans are finalized.
