1. Volunteer Guardianship/Rep Payee Programs Annual Update

Community Outreach & Support Specialist Katie Brietzman reported on program services provided to older adults for the past year but also during the COVID-19 pandemic. Dane County/AAA contracts for both programs with NewBridge Madison. The programs are for older adults with no family or friends support and there is no income limit for the clients. COVID-19 has been a huge challenge for program volunteers: determining the needs of clients and then matching the best volunteer to address the needs; recruiting and training has been difficult with staff needing to attend to their own family needs as well. The quarterly meetings and newsletters are suspended during the pandemic. Many volunteers have been going above and beyond expectations of providing services. AAA Aging Program Specialist Angela Velasquez reported these programs are funded annually with \$25,000 Dane County GPR dollars.
