A motion was made by HELMINIAK, seconded by WEISS, that the Minutes be approved. The motion carried by a voice vote of 7-0.

C. Action Items

1. 2019 Budget Update and Remaining Funds

There is \$800 remaining. \$176.00 will go to Extension for reimbursement for Arbor Day expenses (from marketing/tech fund), FOF expenses still discussing. Branding iron is \$300 plus \$75 from marketing/tech fund, \$250 was previously allocated for Facebook ads.

A motion was made by RITT, seconded by PEARSON, to approve the purchase of branding iron and get artwork done. The motion carried by a voice vote of 7-0.

2. 2020 Budget Consideration, Recommendation and Approval

RITT says there is \$3000 in the budget that County Exec Parisi allocated. RITT and Supervisor Bill Clausius (formerly on the Tree Board) asked for another \$1000 for trees for Arbor Day. The budget goes before EANR soon.

A motion was made by EDDY, seconded by WYATT, approved that a letter be emailed to Personnel and Finance (September 29) and EANR (October 24) advocating for the \$1000 addition. The motion carried by a voice vote. of 7-0.

3. Grants: Discussion/Action

No ATC or DNR grant will be submitted this year, it will be put on a future agenda for 2020 budget discussion

4. Arbor Day: Update/Discussion/Action

Johnson will send out the finalized application to county elementary school STEM teachers and the post-event survey to the 2019 school. A follow-up reminder to apply will be sent out end of November/early December and another in January.

5. Award/Recognition Program: Discussion/Action

EDDY streamlined the application form. Subcommittee will meet and get docs to Johnson. For the next meeting an evaluation criteria packet/application will be attached.

6. Website Update

The subcommittee (BARTELL, HELMINIAK, Johnson) met with Joe Kenealy of Dane County IT re the website redesign. He said that the county is in the process of switching to another system so everything is going to look and work a little differently. The subcommittee will meet to strategize on a plan. Easy fixes are to check links, update members. Suggestions include assigning pages to members to check, and suggesting or creating content.
