A motion was made by ANDRAE, seconded by BAYRD, that the Resolution be amended by striking the word "halt" and replacing it with "suspend" in line 26; striking the phrase beginning with, "preliminary plans" in line 29, through the end of line 32, and replacing it with the following: "the County Board directs the Dane County Sheriff to work with planning, design, and architecture contractors to present options for a smaller, flexible jail facility based on implementation of criminal justice and racial justice reforms and a reduced long-term inmate population;" In line 35, striking the beginning with, "minimize" through the end of line 74; and replacing it with, "strongly urge partners to implement permanent criminal justice and racial justice reforms including those related to diversion, charging and sentencing, jail and department of corrections, and transparency as reflected in 2020-2021 Resolution 180." No vote taken.

A motion was made by BAYRD, seconded by JOERS, to amend the motion to amend by replacing the word "direct" with "urge" in line 32. The motion passed by the following vote: 6-0
