Members discussed the creation of a subcommittee to analyze how the county sets its fees. Supervisor Bayrd explains the rationale behind the need for the subcommittee. Family Services Director Jenny Cook volunteered to assist with the subcommittee. Supervisor Bayrd asked whether citizen members should be a part of the subcommittee. Supervisor Schwellenbach and Supervisor Krause suggested the type of citizen member that would be helpful. Supervisor Bayrd stated that citizen members be paid per diems. Supervisor Rusk suggested inviting groups to identify the problems with fees. Supervisor Krause stated the charge of the subcommittee may be to assess the current state of the use of fees in the County, and to consider potential adjustments. Supervisor Bayrd stated that the new subcommittee should begin in April (after Board elections).
