1. Election of Officers

2. Grant Program Items Needing Attention

The grant applications are due at the end of the work day tomorrow. Lots of phone calls with questions. Habecker will provide the Council on Monday, March 2nd with a link to a Google file that will have all the reviewer resources (review sheets, roster of past awarded grants and grant guidelines) and a folder with the Community Partners applications and a folder with the Capital Equipment applications. Council will have until the March 27th meeting to review and rank the grants.

3. Private Fundraising

American Transmission Company has sent a \$500 check to the Council to assist with funding grants. The check arrived this week. This is due to Jeff Soellner's working with them. No other progress on fundraising.

4. Pollinator Protection Initiatives

Habecker developed and sent out the 2019 Pollinator Progress report to all involved county departments. Progress is being made on the signage for the 2020 public gardens. Funds were transferred to University of Wisconsin Entomology Department so that the club members (graduate and undergraduate Entomology majors) of Insect Ambassadors can be awarded a \$50 stipend for giving pollinator presentations to Dane County school groups. Additionally money was given to a staffer in that department, Katy Thostenson, to refine and make into a digital format the pollinator habitat assessment tool. There is a meeting to begin this work next week. The project should be completed by the end of spring.
