C. Discussion Items

Protocol Update - Dr. Mike Lohmeier

Final changes were made to the protocols. There are 2 versions, a full version and a Field Operator's Guide. The finalized date is dependent on state approval. Lang mentioned page numbers will need to be changed to match PDF. Changes will be shared with agencies for training.

Subcommittee Review of Membership and Ordinance

Members reviewed the committee and subcommittee ordinance. They were then asked to provide feedback on the committee as a whole, including previous successful initiatives, who should be on committee, and how to encourage higher attendance. Carbon mentioned building off ideas from core members who regularly attend. Meier noted committee used to have more field providers who participated. Members agreed committee should maximize hospital and pre-hospital attendance if possible.

D. Presentations

High Performance CPR (HPCPR) Presentation - Dr. Kronenfeld and Dr. Mancera

Dr. Kronenfeld presented data on cardiac arrests and cardiac arrest survival that supports the 2020 High Performance CPR initiative. CARES reports will be used to measure data/outcomes to identify areas for improvement. The initiative will include pulling defibrillator data to review compression quality and pauses in compressions. Dane County has sent people to Resuscitation Academy in Seattle, Washington to train. Dane County's first Resuscitation Academy will be held on March 4 at Alliant Energy Center with the help of two trainers from Seattle. Two members from each EMS agency will be invited to participate.
