Chair Corrigan gave an update on the discussion earlier on 1/23/20 with the CJC members regarding a proposed analysis of Dane County Drug and OWI Courts. Chair Corrigan brought the topic to the CJC since these specialty courts are in the purview of the judiciary and are not fully funded by or within the jurisdiction of the County Board. The judiciary representatives on the CJC and the CJC as a whole indicated that they would like the courts to take on this issue rather than the County Board.
