#### D. Presentations

Continued presentation from Bill Huisheere.

Bill Huisheere provided an update on high school transition data he is gathering in order to compare with Dane County high schools to see if there are any statistical differences with the referrals to the ADRC by race. The data includes the students name, DOB, school they're attending whether or not eligible, race if they are enrolled (including name of the ICA/MCO) or not and if eligible and did not enroll the reason why. Stroman said we have an idea of the prevalence of intellectual and developmental disabilities and those being disaggregated by sub group, we have information on eligibility categories and special education which is not a direct correspondence but can get a rough sense of the prevalence. DPI keeps track of this information for all public high schools in the state. She is interested in whether those rough statistics line up or not. One of the reasons that propels her to that inquiry is because the legacy county system and the grad policy would have excluded students who weren't able to stay in school until 21 or were not successful in meeting requirements having a job upon exit or other reasons. Stroman is curious if that would have an effect in filtering out the students who either dropped out or did not meet the grad policy requirements who otherwise would have qualified on a functional screen basis or adult long term care services.

Yochum said there is a new dental clinic in Madison on the west side that accepts Medicaid patients, Bright Dental.

# **G. Board Members Report**

Kilmer reported that Health and Human Needs has a subcommittee, behavioral mental health subcommittee they will be working at awarding the grants from the money allotted in the county budget to fill in gaps in the mental health and behavioral health care. There were public hearings and now it has gone to RFP. Along with the grants also funded is a resource center for people who cannot find care for behavioral and mental health. They will help people connect them to care regardless of coverage.

Olson said there was a bill that passed the legislature to reduce the hours of training for CNA's. It was approved and the governor vetoed. There is concern that the legislature will try to override the veto.

The care act and the income tax credit, working with AARP on that issue. Volunteer drivers reimbursement, issue is the increased insurance costs for volunteer drivers and at times their insurance company will refuse to cover them if they are a volunteer driver. Federal level there is reauthorization of the Older American's Act.

Esbeck said he will be going to the national advocacy conference in March for the Alzheimer Association.

Nichols said the governor signed off on a bill last week that deals with violence in the work place toward health care workers. The law allows the health worker to report this.

## H. Manager's Report

Fischer provided an overview of the statistics.

With the transition My Choice Family Care Care WI is the only family care option. Community Care will be coming May 1, 2020, which will be a second family care option in Dane County.

My Choice Family Care Care WI has been doing reorganizing with the management staff, and reshuffling of care teams.

This week on Wednesday there is celebration of Dementia Friendly communities at Warner Park. First Lady Kathy Evers will be there along with County Executive, Joe Parisi to do a welcome.

Fischer informed the board of staff changes occurring at the ADRC.

ADRC is participating in a Hispanic Resource Fair that East High School is doing in March.

Fischer said she is on the committee for the Mental Health Resource Center planning and development. She is attending these meeting on a monthly basis.

Fischer reported the VA Hospital is interested in participating in the Veterans Fair again this year. The ADRC also plans to repeat the care giver event this year.

Fischer said she participates in a select workgroup of ADRC's that meet with the Office of Resource Center Development to talk about reinvestment in ADRC's.
