Tessmann reported:

- •Airport Collection Boxes: We would need four boxes with upfront costs of \$12,000 and the ongoing cost of an armored truck for collection. Funds were not authorized in the budget amendment. Milwaukee collected \$12,000 and with fewer visitors through the Madison airport projections would be \$4,000-\$5,000 per year, so the benefit may be more about raising awareness. Other community groups are not supportive. Committee members asked about raising awareness in other ways. Staff will explore.
- •Bid waiver update: Link to bid waivers will be forwarded to Committee.
- •RFP letter to POS: will be forwarded to HHN
- •Engaging HSB in strategic planning effort draft sent to HHN. The County Board staff is reviewing other counties' Human Services Boards.
- •JMH Update: electronic health record system is being used, crisis billing through DCDHS is being discussed, crisis staffing struggles continue due to competition, utilization rates and trends are being monitored, DCDHS management team toured the Kessel Court office.
