E. Reports to Committee

Madison Fire HazMat Team Report - Mrowiec

Mrowiec reported incidents the HazMat Team responded to since the last committee meeting. These included: October 24 response to high levels of CO2 that was determined to be caused by forklift on charger; January 8 response to 6-8 pounds of mercury spilled in private residence; January 23 gas leak in downtown Madison; January 31 response to private resident receiving unknown vials of liquid from Taiwan, FBI tests came back as not dangerous. Mrowiec also reported to committee that Madison Fire Department has been awarded a \$160,000 grant from Wisconsin Emergency Management that will be used to purchase new hazardous materials detection equipment.

HazMat Planning - Bursack

Busack reported to committee that Dane County renewed its hazardous materials contract with the City of Madison for 2 more years. Bursack updated committee on EPCRA plans that are completed and currently being worked on. Wisconsin Emergency Management has asked to have all 206 plans put into WHOPRS (Wisconsin Hazmat Online Planning and Reporting System) for this year's Plan of Work. Bursack shared data with committee regarding the number hazardous material responses in Dane County in 2018 and 2019. Bursack presented case study on emergency management response during the Sun Prairie Gas Explosion. Information shared included the need in this situation for a no-notice evacuation, Dane County Emergency Management's involvement in the response, early considerations for social media response, and focus on long-term recovery. Bursack informed committee that the Radiological Response plan had been updated in 2019 and invited members to the tabletop exercise for this plan scheduled for March 18, 2020.

Williams reported to committee that Red Cross is involved in the planning for the Democratic National Convention taking place in Milwaukee in 2020.
