Public Comment:

Jody Bartnick spoke in support of the Community Assistance Recovery Effort (C.A.R.E.) Package. She is the Executive Director of 4-C who will administer the contract to sustain/reopen daycare centers in Dane County. An email with tracking will be sent to all 500 daycares with follow up phone calls to those who don't respond to the simple survey. She gave an overview of 4-C and some statistical information on daycare owner/operators. Bartnick and Tessmann answered questions.

A motion was made by BARE, seconded by WEGLEITNER, that the Resolution Requiring 2/3rds Vote be postponed to the Health & Human Needs Committee, due back on 5/28/2020, with instructions to staff to bring back an amended contract with the goal of improving both access and quality, with a priority placed on: Workforce support, PPE and processes for pandemic safety, and lost revenue due to the pandemic.
