Sheriff David Mahoney made opening remarks regarding the remarkable efforts of various entities within law enforcement and the judicial system to temporarily reduce the jail population in response to COVID-19. The pandemic has exposed the dire need for medical housing within the jail to address inmates with significant medical issues. Additionally, the opioid epidemic has created a need to develop programming for Medication Assisted Treatment. Post jail consolidation, vacated inmate housing on the 3rd floor could provide space for addiction treatment and other programming.

-Developing fixtures, furniture and equipment lists.
-Bids to relocate electrical service vault due June 16, 2020.
-Courthouse and PSB properties have been combined into a single parcel/property.

-Exterior Design: -Façades and street level loading docks viewed in relation to surroundings.

-Interior Design:

- Viewed Virtual Tour of the building interiors.

-Guided by biophilic design principles to incorporate nature using color, texture, shapes, light and images.

-Color palettes of blue, aqua and green will promote calmness.

-Skylights and exterior windows provide natural light to support circadian rhythm.

-Use of texture and color on floors and ceilings to define spaces within larger units.

-Sustainability Initiatives:

-Storm water management with Blue Roof & Green Roof -Focus on Energy Program. Targeting \$100K in incentives.

-Next Design Steps 2020
